SUMMARY OF THE PROCEEDINGS OF 8th ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

The 12th Annual General Meeting of the Company was held on Friday, 16th September 2022 at 11.30 AM through Video Conferencing.

PROCEEDINGS IN BRIEF

- Mr. Rajesh Kumar Negi, Chairman & Managing Director of the Company occupied the chair.
- Total 10 members including members from Promoter group were present in the meeting.
- As per Section 103 of the Companies Act, 103 the required guorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 12th AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- With the consent of the Members present the notice of the 12th AGM and the Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 12th AGM was provided to the Members of the Company from 9.00 am on 13th September 2022 and up to 5.00 pm on 15th September, 2022 and that the e-voting module was closed by NSDL thereafter.
- One member had registered as speaker for the AGM but he/she did not address the meeting. The Chairman thereafter requested the Members who had not voted through remote e-voting to vote through the e-voting process provided at the AGM. Mrs. Kriti




